- The Gujarat Maritime University (GMU), set up under the Gujarat Private Universities Act, 2009 is an endeavor by the Government of Gujarat through the GMB to provide a fillip to the growth of Indian Maritime Sector and to bridge the knowledge gap within the industry.
- The university has been set up following the Hon'ble Prime Minister's vision of setting up a think tank in the maritime sector. To address the growing need of trained professionals in the maritime sector, especially for commercial roles, the university began its academic journey in 2019 by offering industry-tailored courses. Working closely with professionals from the maritime industry, academia and the government, GMU is one of the first of its kind university in India offering programmes comparable with leading international maritime universities.
- The Governing Body of the university consists of senior officials of the Government of Gujarat, top industry leaders and academicians and is led by the Chief Secretary to Government of Gujarat.



The GIMAC is conceived as a specialist Alternate Dispute Resolution (ADR) center with a mission to organize and manage arbitration proceedings in disputes pertaining to different sectors, with special focus on commercial disputes pertaining to maritime and shipping sector.

Being developed under the aegis of the GMU, GIMAC is housed in the Gujarat Maritime Cluster (GMC) eco-system at the Gujarat International Finance Tec (GIFT) City, Gandhinagar.

The GIMAC envisions to provide an alternate dispute resolution mechanism for the Indian shipping and maritime stakeholders, who currently depend on overseas ADR centers because of the absence of a dedicated maritime ADR center in India. GIMAC has developed world class Hearing Rooms, Breakout Rooms and other top class infrastructure comparable with best arbitration centers across the globe.

The GIMAC also envisions to be an efficient ADR center with rules and regulations matching other globally renowned maritime arbitration institutions.

- Maritime sector is the backbone of international trade and global economy.
- Around 90% of the world trade is carried out by the international shipping industry and job opportunities in maritime and shipping is directly proportional to the volume of world trade.
- Global reports indicate that India will be one of the top 3 countries in the world by 2030. If that has to happen, the maritime and shipping sector will have to play a prominent role.
- Recent estimates of manpower deployment in maritime sector in India indicate the demand-supply gap (shortage) of more than 50 thousand management professionals in the conservative scenario and about 2 lakh management professionals in the average-case scenario by 2030. This implies a huge demand for skilled maritime professionals.
- In India, there are around **150** Directorate General of Shipping approved institutes offering a variety of courses, covering both technical and commercial aspects in the maritime sector. However, the ratio of institutes providing technical and commercial courses in India is **92:8**, whereas the ratio of job requirement in technical and commercial areas is **60:40**.
- There is a dearth of institutes in India providing commercial maritime education, due to which, students interested in pursuing commercial courses are compelled to study outside India, incurring huge costs.

All these facts leads to the fact that pursuing a career in the maritime and shipping sector is a lucrative career option, which many are unaware about. It also points to the priority need of adding capacity in the commercial side of the maritime sector.

The 50-acre sprawling transitory campus at GNLU strives to reduce its environmental impact by incorporating sustainability in every aspect of campus life. The lush and luxuriant environs form an ideal seat for learning.

The campus is equipped with modern facilities and latest technology to provide an excellent learning environment for the students. The institute has state-of-the-art classrooms equipped with multimedia equipment and modern furniture, fully equipped conference rooms with video-conferencing facility, a 24x7 library and a computer lab with latest configuration machines as well as access to various software and databases.
