
About GMU

History and Background

The Indian Maritime sector has been consistently exhibiting strong growth and is slated to be the maritime economy of the future. The establishment of Gujarat Maritime University (GMU) is an endeavour by the Gujarat Maritime Board to provide a fillip to this growth by bridging the knowledge gap within the industry.

Gujarat Maritime University was formed in 2017 under the Gujarat Private Universities Act, 2009 and commenced operations in 2019. The prime objective of Gujarat Maritime University is to be a global center of excellence in maritime education, research and development, professional training. It aims to enhance and increase the human capital and capacity of maritime industry both in India and across the globa. The aspiration is to serve the global maritime community by producing educated and well-trained professionals in the maritime domain.

In the first phase, the University has started offering Masters and Post Graduate programmes catering to the commercial aspects of maritime value chain like maritime law, maritime management, international trade law, logistics, just to name a few. The university has also started offering short-term certificate courses and executive development programmes for professionals in collaboration with foreign partners and institutions such as Erasmus UPT, STC International, Indian Institute of Management (Bangalore) etc. In the future, the University will expand its offerings in phase one by introducing additional programmes. GMB's unique business model has successfully placed Gujarat's nonmajor ports as a role model for other states to follow.

This has led to GMB initiating several key projects to enable growth at an accelerated pace. GMU is one such prestigious project of GMB.

GIMAC's primary objective revolves around expediting and ensuring effective resolution of disputes concerning the maritime and shipping sectors. It was the need to address India's unfavourable position (163rd among 189 countries) in terms of honouring business contracts, which entails prolonged dispute settlement durations and exorbitant expenses, that prompted the establishment of GIMAC. Furthermore, the absence of any dedicated arbitral institutions in India focussing solely on maritime and shipping disputes has compelled Indian enterprises to resort to arbitration centres in prominent global cities such as London, Singapore, and Hong Kong. By harnessing the expertise of accomplished arbitrators and legal professionals, GIMAC envisions to position itself as a formidable contender among renowned maritime arbitral institutions worldwide.

In an exceptional opportunity presented to Gujarat Maritime University students, GIMAC allows them to engage in live projects within the realm of arbitration and mediation while concurrently pursuing their academic endeavours.



Security: Piracy, illegal fishing, and other maritime crimes pose ongoing challenges. Maritime law professionals may work on legal and policy solutions to these problems.



Admission Process

LL.M Programmes

Eligibility

The candidate should possess an LLB/Equivalent Degree in law from a recognized University with a minimum of 50% marks or an equivalent grade for general category/OBC/PWD/NRI/PIO/OCI candidates, and 45% marks or an equivalent grade for candidates belonging to the SC/ST category.

Candidates who are in the final year of their qualifying examination or have completed the degree requirements and are awaiting results may also apply. If selected, these candidates will be provisionally allowed to join the program, subject to fulfilling all requirements and meeting the eligibility criteria within the specified timeframe.

Selection Process

The selection for the programme will be based on a National Level Online Remotely Proctored entrance test followed by a Personal Interview of the candidates. The weightage of the selection process will be as follows:

Criterion	Weights
Remotely Proctored Online MCQ Test	70%
Personal Interview	30%

In case, if any seat remains vacant after the conclusion of the GMU LL.M. admission process, the same will be filled on the basis of merit secured by the candidates in Common Law Admission Test (CLAT) – 2023. CLAT-2023 aspirants are also required to make an application for admission by following the aforementioned process and select CLAT-2023 as the mode of admission.

Entrance Test

The remotely proctored online entrance test will include 70 Objective Type Questions (MCQs) each question carrying one mark. The duration of the test will be 60 minutes. There will not be any negative marking for wrong answers. The question paper will be based on the core subjects of the undergraduate integrated LLB or LLB Programme and will include Constitutional Law, Jurisprudence, Administrative Law, Law of Contract, Torts, Criminal Law and Public International Law. 
Programme in Law

Global Externship Programme



The Global Externship Programme (GEP) offered by Gujarat Maritime University (GMU) provides a unique opportunity for students to gain international exposure by spending a part of their course at the highly regarded Erasmus University in Rotterdam, known for its excellence in maritime education and research. As part of the GEP, students engage in various activities, including classroom training, moot court competitions, and off-campus excursions to ports and shipyards. Recently, GMU successfully completed its inaugural two-week GEP at Erasmus University, enabling 34 students to gain valuable insights into the European maritime sector and interact with industry experts and faculty members. The GEP is designed to deliver world-class education and to promote cross-cultural exchange of valuable information. The GEP is an integral component of GMU's programme structure and is governed by an agreement signed between GMU and the Erasmus Centre for Urban, Port and Transport.



Flagship Events and Student Activities

Gujarat International Maritime Arbitration Competition - GIMAC 2022, 2021, 2020

The Gujarat International Maritime Arbitration Competition (GIMAC) is an annual flagship event hosted by GMU since 2020, attracting over 100 participants across 34 teams each year, including international participants and National Law Universities teams. The competition simulates an arbitration process for maritime disputes such as cargo disputes, shipping contracts, and marine insurance claims and provides participants with opportunities to enhance their knowledge of maritime law, advocacy skills, and practical experience in resolving such disputes. 
Student Life

At GNLU Campus, Attalika Avenue Knowledge Corridor, Koba, Gandhinagar Gujarat – 382426

GMU's transitory campus is in Gandhinagar, the capital city of Gujarat state. The best way to reach Gandhinagar depends on your location and personal preferences. From there, you can hire a taxi or take a bus to reach GMU.

From Sardar Vallabhbhai Patel International Airport

The distance between the nearest airport, Sardar Vallabhbhai Patel International Airport in Ahmedabad, and GMU's transitory campus is 14 kilometers. The journey from the airport to GMU by via the Gandhinagar – Ahmedabad Road takes approximately 20-35 minutes.

From Gandhinagar Railway Station

The distance between Gandhinagar Capital, Gandhinagar's railway station located in Sector 13C, 14 and GMU's transitory campus is approximately 14 kilometers. The journey from the railway station to GMU by via the Gandhinagar – Ahmedabad Road takes approximately 25-35 minutes.

From Ahmedabad Railway Station

The distance between Ahmedabad railway station and GMU's transitory campus is approximately 21 kilometers. The journey from the railway station to GMU by via the Gandhinagar – Ahmedabad Road takes approximately 35-55 minutes.

From Gandhinagar Bus Depot
