

1st International Trade Conclave at Gujarat Maritime University

The **Centre for Maritime Economy (CME)** at Gujarat Maritime University successfully organized the **1st International Trade Conclave** on **10th March 2026** at the **GMU Campus, Gandhinagar**.

The conclave featured engaging and insightful interactive sessions and workshop facilitated by Anand Mirani, Strategic & Legal Advisor at Simplus Exim & Corporate Advisory LLP. The conclave was designed to bridge the gap between **academic understanding and real-world international trade practices**, providing participants with practical exposure to global trade frameworks.

◆ Session Highlights

Session 1 – International Business, Trade Policy & Classification Systems

Participants were introduced to a comprehensive **five-pillar framework for international trade**, covering:

- Foreign Trade Policy Mastery
- World Customs Organization
- FEMA & RBI Guidelines
- Effective Logistics Management
- Risk Mitigation Planning

The discussion also explored the **HSN Classification System** and **ITC-HS framework**, helping participants understand how classification plays a crucial role in trade compliance and documentation.

Session 2 – Incoterms® 2020

The second session focused on the **strategic application of the 11 Incoterms® 2020**, highlighting delivery points, transfer of risk, and commercial considerations ranging from **EXW to DDP**. Through real-world export-import case studies, participants gained valuable insights into how incorrect Incoterm selection can lead to documentation errors, financial losses, and shipment disputes.

A key takeaway from the conclave was that **Incoterms are not merely logistics terms but strategic business decisions** that govern risk allocation, cost responsibilities, documentation, insurance, customs obligations, and payment structures in international trade.

Session 3 – Research Presentations

Students of MBA made detailed presentations on strategic aspects of India's International trade, India's global trade relations with a focus on maritime trade routes. The discussion centre around countries like:

Australia | Belgium | Brazil | China | France | Germany | USA | New Zealand | Russia | Saudi Arabia | Singapore | South Africa | South Korea

The research work was guided by Dr. Dharmesh Raval, Director – School of Maritime Management.

The conclave witnessed enthusiastic participation from students, with interactive discussions and practical examples that connected theoretical frameworks with real trade scenarios.
